## **EXECUTIVE SUMMARY**

Amidst a depressing era in the race against climate change-with killer fires and titanic storms, political stalemate and corporate greenwashing-the fossil fuel divestment movement is a source for tremendous optimism.


Ten years in, the divestment movement has grown to become a major global influence on energy policy. There are now 1,485 institutions publicly committed to at least some form of fossil fuel divestment, representing an enormous \$39.2 trillion of assets under management. That's as if the two biggest economies in the world, the United States and China, combined, chose to divest from fossil fuels.

#### A BROADER AND DEEPER MOVEMENT

While the overall growth of the movement is clear by the growing number of commitments, the depth and breadth of the movement has also expanded.

There are now institutions committed to fossil fuel divestment in 71 countries, up from the 37 recorded in the movement's most recent report from 2018.<sup>22</sup> In 2014, only 22 percent of divesting institutions were based outside of the U.S. But by 2021, that has climbed to 69 percent, signifying the globalization of the movement.<sup>23</sup> The diversity of institutions and their average size has also grown, and now includes more and more high-profile institutions. Large insurance companies, pension funds, and universities with massive endowments have driven the biggest increases in assets under management committed to divestment, while faith and philanthropic institutions have driven the largest increases in the number of commitments in recent years.

The philanthropic sector has stepped up its commitments significantly. The Divest-Invest Philanthropy coalition first launched in January 2014 with 17 foundations, holding combined assets of nearly \$2 billion, publicly committing to both divest from all fossil fuels and invest at least 5 percent of their portfolio in climate solutions. As of October 2021, there are 192 foundations and family funds with assets over \$125 billion committed to divestment in some form.

## What's the problem with fossil fuels?





**Fossil fuels literally fuel the climate crisis**. As we burn oil, gas and coal, carbon is released into the atmosphere. Carbon emissions amplify the 'greenhouse effect' which warms the planet.

The dangerous warming we're seeing is 'unequivocally' the result of human activity, as stated by the Intergovernmental Panel on Climate Change. These planet-warming activities – namely, the burning of fossil fuels – produce more wildfires, flooding, sea-level rise, droughts and other climate disasters.



## But don't we need fossil fuels?

In 2021, the International Energy Agency (IEA) announced the world has more than enough oil and gas already – more than we can even afford to safely burn as we make the global transition to renewable energy – and that **all new oil/gas developments must be stopped**.

The Intergovernmental Panel on Climate Change (IPCC) has said that for the world to limit global warming to 1.5°C, and thus avoid the worst impacts of the climate crisis, **carbon emissions must be halved by the end of this decade**.





## But what about the price of energy?

 New oil and gas projects will only worsen the energy problem in the UK, which is over-reliant on gas. More fossil fuel-drilling won't lower household bills, as even UK Business Minister Greg Hands has admitted ("It's the global price [of gas] that sets the UK price").



 To lower energy bills, the government needs to redirect new investment into more affordable, domestically-produced renewables and better insulation for British homes. It's now cheaper to generate electricity from renewables than it is from gas.

#### No indication of shifting away from fossil fuels

Between 2009 and 2020, none of the four companies generated renewable energy on a scale that would "indicate a shift away from fossil fuels", despite all showing a significant increase in references to "climate change", "transition", "emissions" and "low carbon energy" in their annual reporting.

According to the research, ExxonMobil generated no electricity from clean energy sources between 2009 and 2020. Chevron generated just 65.5 megawatts.

Of the four, BP generated the most with around 2,000 megawatts, or "the equivalent of around two large gas-fired power-plants", the researchers said.

In energy equivalent terms, this pales in comparison to the 2 million or more barrels per day each company produced on average during the study period.







#### Church of England fund managed by CCLA exits from fossil fuel investments

One of the Church of England's three National Investing Bodies, which is managed by investment management company CCLA, has recently sold its last remaining shares in fossil fuel companies.

CCLA, whose CBF funds manage investments on behalf of most Church of England dioceses and many local CoFE churches, said it had dropped its investments in oil giants Shell and Total for financial reasons earlier this year.



### Church of England: still invested in fossil fuels

Two of the Church of England's three national investment bodies – the Church Commissioners and Pensions Board – collectively have **approximately £55 million invested in fossil fuels**.

Some individual Church of England dioceses also still have fossil fuel investments. In fact, **only 10 of 42 Church of England dioceses have divested from fossil fuels and made a formal commitment never to invest in fossil fuels in the future**.
